The insurance certificate requirements are as follows:

- The insurance company shall have a minimum Best Rating of A-1.
- The minimum limit of liability shall be \$1,000,000.00.
- The policy coverage shall be Comprehensive and on an Occurrence form.
- **New Lenox Community Park District**, 701 W Haven Ave. New Lenox, IL 60451 and **Menards Inc.**, 601 East Lincoln Highway, New Lenox, IL 60451 shall be named as Additional Insured.

The management reserves the right to ask that any item, which may be considered dangerous or hazardous, be removed at any time during the fair.

Location: Show is located OUTSIDE, 601 East Lincoln Highway, New Lenox, IL, 60451 in the east parking lot of Walmart. Signs will be visible when you arrive.

**You are required to bring your own table and chair.** You may bring a tent which cannot be bigger than 10 x10. You must be able to secure tent down without putting stakes in the ground.

Your booth must not interfere with adjacent booths in any way.

Electric hook-up is not available.

Booth set up will be staggered; booth must be completely set-up by 10:00am.

You will be able to park one car behind your booth space. A diagram will be provided later.

You may not break down early.

Festival Food Vendors will be open at Noon.

You are required to clean-up your space at the end of the show.

You are not allowed to bring your pets.

Use of sound systems, glass bottles and loud generators are prohibited.

No smoking under tents.
